2. Update from the Practice.

- 2.1. There are difficulties in getting someone to clear and maintain the drainage system.
 Significant rainy conditions are causing damp in the two end rooms and efforts are in place to dehumidify these.
- 2.2. The **consultation** on Evington surgery finished on the 10th of September. A report will be sent to the Integrated Care Board (ICB) and the closure of the surgery is expected to be late November, early December.
- 2.3. **Downing Drive surgery** are currently evaluating their catchment area and accepting patients from Evington.
- 2.4. The practice is still recruiting for a **pharmacist**. It is proving challenging.

3. Any other Business.

3.1. **Willows Health surgery**, at 1 Evington Lane, are accepting patients. This can support patients that are registered with Evington surgery.

- 3.2. Work is being done to produce a work-plan for **preventative maintenance** of the surgery. Preventative maintenance aims to keep things maintained in a timely manner, so that they do not become bigger and more expensive issues later.
- 3.3. **Medicine reviews** are to be organised over the next 12 months once all patients from the Evington surgery have been reallocated.
- 3.4. Flu jabs will be rolled out from October.
